

MGNREGA in Andhra Pradesh

860. SHRI V. VIJAYASAI REDDY: Will the Minister of RURAL DEVELOPMENT be pleased to state:

(a) total amount allocated by the Ministry for MGNREGA to the State of Andhra Pradesh during the last three years and the current year, year-wise;

(b) details of household families that have sought employment and got employment under MGNREGA during the above period, district-wise;

(c) details of assets created, district-wise, during the above period;

(d) whether Ministry found any diversion/irregularities in implementation of MGNREGA in Andhra Pradesh and

(e) if so, details thereof and action taken by the Ministry on the same?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV): (a) Mahatma Gandhi National Rural Employment Guarantee Act, 2005 (MGNREGA) is a demand driven wage employment scheme, hence no State/UT-wise allocation of fund is made. As per the Government of Andhra Pradesh, the details of Central fund released during the last three financial years and the current financial year 2018-19 (as on 05.02.2019) under the MGNREGA are given below:—

Since the responsibility of implementation of MGNREGA is vested with the State Governments/UTs, all complaints received in the Ministry are forwarded to the concerned State Governments/UTs for taking appropriate action including investigation, as per law.
