Monitoring Committee named as "DISHA", submission of reports by third party monitoring through National Level Monitors, Area Officers Schemes, Concurrent Evaluation, Impact Assessment Studies, monitoring the submission of Utilization Certificates. As per the reports/returns received from the State Governments/UT Administrations, the implementation of these programmes have been found to be satisfactory. Independent studies have also observed positive socio-economic impacts of rural development programmes in rural areas.

## Discrimination against differently-abled persons under MGNREGA

864. SHRI TIRUCHI SIVA: Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether Government is aware that differently-abled persons continue to experience discrimination under MGNREGA scheme;
- (b) whether the number of differently-abled persons employed under the MGNREGA scheme has increased in the last year and if so, the details thereof; and
- (c) details of steps being taken by Government, particularly in the State of Tamil Nadu, to increase the participation of differently-abled persons in employment activities in the rural areas?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV): (a) and (b) The Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), 2005 provides at least one hundred days of guaranteed wage employment in every financial year to every rural household whose adult members volunteer to do unskilled manual work. The details of number of differently-abled persons worked under the MGNREGA during the last three financial years and current financial year 2018-19 (as on 06.02.2019) is given below:—

- (c) State Governments including Tamil Nadu have been advised to take the following steps for increasing the participation of differently-abled persons under MGNREGA:-
  - States to identify specific works which can be done by differently-abled persons;

- (iii) Differently-abled persons should be given preference for appointment as Mates for MGNREGA works and as workers for providing drinking water, to manage crèches etc., at the work site.
