

authentication/any other technical reasons. Also no person/households shall be deleted from the list of eligible household database only for reason of non-possession of Aadhaar number by beneficiary/ration card holder.

Following the order of Hon'ble Supreme Court of India dated 26.09.2018, regarding requirement of Aadhaar for receiving any subsidy, benefit or service under the welfare scheme of the Government, it has been re-iterated *vide* this Department instructions dated 08.11.2018 that no genuine beneficiary shall be denied subsidized foodgrains on the grounds of non-possession of Aadhaar.

Further, no incidence of cancellation of priority ration cards for want of Aadhaar number leading to death of any beneficiary has been reported to this Department.

Requirement of quality seeds

*67. SHRI SYED NASIR HUSSAIN: Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

(a) whether demand of quality seeds has been increasing over the last three years, if so, the details of demand for quality seeds in the country for current year and last three years;

(b) in what manner the requirement of seeds during natural calamities like flood, drought, etc., would be met and details of seeds reserved in the National Seed Reserve;

(c) whether Government provides financial assistance to States and seed-producing agencies for production and distribution of seeds, if so, details thereof, State-wise; and

(d) the crop development programmes/schemes meant for production and distribution of seeds, details thereof?

THE MINISTER OF AGRICULTURE AND FARMERS WELFARE (SHRI RADHA MOHAN SINGH): (a) The demand of quality seeds in the Country for the current year and last three years as reported by the States is 337.09 lakh quintals in 2015-16, 353.49 lakh quintals in 2016-17, 371.38 lakh quintals in 2017-18 and 353.55 lakh quintals in 2018-19.

(b) To meet the demand of seeds during the natural calamities like flood and drought etc., the stress tolerant rice varieties *i.e.* flood tolerant, drought tolerant and salt tolerant paddy seeds and short and medium duration crop varieties seeds are produced and distributed to the farmers. The details of seeds reserved in the National

Seed Reserve during last three years and current year is are given in Statement-I (See below).

(c) The Government of India provides the financial assistance to the States and seed producing agencies for production and distribution of seeds through various ongoing crop development programmes/schemes viz. National Food Security Mission, Bringing Green Revolution in Eastern India, Mission for Integrated Development of Horticulture, Rashtriya Krishi Vikas Yojana, National Mission on Agricultural Extension and Technology (Sub-Mission on Seeds and Planting Materials), etc. State wise and scheme wise details of financial assistance provided during current year are given Statement-II (See below).

(d) The details of various crop development programmes/schemes for production and distribution of seeds are given in Statement-III.

**Implementation of MSP as per Swaminathan
Committee recommendation**

*68. SHRI RAM KUMAR KASHYAP: Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

(a) whether Government plans to set Minimum Support Price (MSP) at 1.5 times of the comprehensive cost, as per recommendation of Swaminathan Committee, if so, the details thereof and by when the Committee's recommendation would be implemented and if not, the reasons therefor;

(b) whether Government has received any proposal for implementation of the above recommendation of the Swaminathan Committee, if so, the details thereof and the response thereto; and

(c) whether market price for 10 out of 14 Kharif crops was lower than MSP announced by Government, if so, the details thereof?

THE MINISTER OF AGRICULTURE AND FARMERS WELFARE (SHRI RADHA MOHAN SINGH): (a) and (b) National Commission on Farmers (NCF) headed by Dr. M.S. Swaminathan had recommended that the Minimum Support Price (MSP) should be at least 50 per cent more than the weighted average cost of production. However, when the National Policy for Farmers, 2007 was finalized by the then Government, this recommendation of providing 50 per cent returns over cost of production was not included.

While recommending MSPs, CACP considers the cost of production and host of factors such as demand-supply situation, trends in domestic and international prices, inter-crop price parity, terms of trade between agricultural and non-agricultural sectors and the likely impact of MSP on consumers and overall economy along with rational
