

(c) whether Government is facing problems in deporting identified/Rohingya Muslims to Bangladesh or Myanmar; and

(d) if so, the details thereof and Government's response thereto?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI KIREN RIJJU): (a) and (b) Since illegal immigrants enter into the country without valid travel documents in clandestine and surreptitious manner, there is no accurate data regarding number of such migrants including Rohingyas staying in the country.

(c) and (d) Detection and deportation of all illegal immigrants is a continuous process and depends upon nationality verification by the concerned foreign Government. India does not discriminate between foreign migrants based on their religion. As per information available, 12 Myanmar nationals were deported recently after following due process as per directions of various courts.

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI KIREN RIJJU): There are no Meetings of the Official Language Hindi held under the Chairmanship of the Secretary of the Secretariat. However the meetings of Hindi Advisory Committees are held in every Ministry/Department under the Chairmanship of Hon'ble Ministers of the respective Ministry/Department.

Hindi Advisory Committees have been set up in various Ministries/Departments to advise on proper implementation of Official Language Policy of the Government of India. These Committees are chaired by the concerned Ministers and these are constituted in accordance with the guidelines formulated on the recommendations of the Central Hindi Committee which is chaired by the Prime Minister. There are 55 Hindi Advisory Committees constituted in Central Government Ministries/Departments. The tenure of Hindi Advisory Committee is 3 years. The members of Hindi Advisory Committee includes-

The Department of Official Language sends directives regarding reconstitution and regular meetings of Hindi Advisory Committee from time to time. It is obligatory on the part of respective Ministries/Departments to hold the meetings of Hindi Advisory Committee as per the Official Language directives.
