Reduction of Stake in PSUs

996. SHRI K. C. RAMAMURTHY: Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

(a) details of companies in which Government has 51 per cent or more stake, PSU-wise;

(b) whether it is a fact that Government has decided to reduce its stake in all PSUs to 49 per cent without consulting the PSUs and other stakeholders;

(c) the reasons for the same in spite of the fact that there are some PSUs which are strategically important for the country;

(d) reasons as to why the Ministry says that only disinvestment will make the Boards of these companies professionally managed; and

(e) whether NITI Aayog recommended to bring down Government's stake in PSUs?

THE MINISTER OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (SHRI ARVIND GANPAT SAWANT): (a) As per the Public Enterprise Survey (PES), which is laid every year in both the Houses of the Parliament by Department of Public Enterprises (DPE), certain statutory corporations and all Government Companies in which more than 50% equity is held by the Central Government are classified as CPSEs. The Subsidiaries of these Companies in which any CPSE has more than 50% equity are also categorized as CPSEs, if registered in India. There are 339 CPSEs as on 31.03.2018, out of which 257 are operating CPSEs and 82 are under construction. The list of 257 operating CPSEs is given in Statement (See below).

(b) and (c) No, Sir.

(d) No, Sir. Department of Public Enterprises (DPE) has not made any such observation that only disinvestment will make the Boards of the CPSEs professionally managed.

(e) The information will be collected from NITI Aayog and will be submitted accordingly as they do not fall under the administrative Ministry of Heavy Industries and Public Enterprises.
