In addition to the above clearances by respective Ministries, signing of MoU for implementation between Governments of Maharashtra and Gujarat, funding pattern, constitution of Special Purpose Vehicle/Authority for implementation, etc., are the pre-requisites before commencement of the project.

Increasing of piped water to households

1017. SHRI RAM KUMAR KASHYAP: Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether Government has decided to increase coverage of piped water tohouseholds from current 18 per cent to 100 per cent by 2024;
 - (b) if so, the details of the scheme formulated in this regard;
 - (c) the present status of coverage of piped water to households, State-wise;
- (d) the details of States having less than five per cent coverage of piped water of households;
 - (e) the per capita water availability; and
 - (f) the quantum of amount allocated for the scheme?

THE MINISTER OF STATE IN THE MINISTRY OF JAL SHAKTI (SHRI RATTAN LAL KATARIA): (a) and (b) Yes Sir. The matter is under consideration of the Government.

- (c) and (d) As per information furnished by the States on Integrated Management Information System (IMIS) of the Ministry, the present State-wise status of coverage of piped water supply connections to rural households is in Statement (*See* below). States of Assam, Bihar, Goa, Meghalaya, Nagaland, Odisha, Tripura, Uttar Pradesh and West Bengal are having less than 5 per cent coverage of piped water supply connections to rural households.
- (e) As reported by States on Integrated Management Information System (IMIS) of Department of Drinking Water and Sanitation, out of total rural population of 9182.58 lakhs, 7001.42 lakhs rural population (76.25%) are getting more than 40 litres per capita per day safe drinking water, 1815.74 lakhs rural population (19.77%) are getting less than 40 lpcd safe drinking water and 365.41 lakhs rural population (3.98%) are residing in the areas where drinking water is chemically contaminated.
- (f) For the financial year 2019-20, the NRDWP has been allocated an amount of ₹10000.66 crore.
