

**Production in Getalsud food park in Ranchi**

†3116. SHRI MAHESH PODDAR: Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether it is a fact that the food park in Getalsud near Ranchi in Jharkhand is reportedly functional;
- (b) if so, the details of total production, number of labourers along with the electricity consumption therein during last five years;
- (c) the details of the subsidy given by the Central Government to this food park till date;
- (d) the names of the banks and the amount that remains outstanding against the said food park; and
- (e) the details of the ownership of this food park?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD PROCESSING INDUSTRIES (SHRI RAMESWAR TELI): (a) No Sir. The Mega Food Park has become non functional due to the demise of the lead promoter [whole time Director] in the year 2017.

- (b) Does not arise.
- (c) Ministry has released ₹ 43.78 crore to this park.

(d) M/s Allahabad Bank, Harmu Colony Branch, Ranchi, Jharkhand has sanctioned term loan amounting to ₹ 33.95 Crore to M/s Jharkhand Mega Food Park Pvt. Ltd. to establish Mega Food Park projects at Village Getalsud, District Ranchi, Jharkhand. As per the information provided by Allahabad bank on 18th June, 2019 to Ministry, bank dues are amounting to ₹ 46.27 Crore towards this project.

(e) Details of ownership through shareholding of M/s Jharkhand Mega Food Park Pvt. Ltd for the said Mega Food Park is as under:
