## Private investment in education

- \*103. SHRI A. VIJYARAGHAVAN: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:
- (a) whether there is any proposal from any source, including the Planning Commission, to set up a policy frame-work for facilitating private investment in education;
  - (b) if so, the details and the present status thereof;
- (c) whether there is any proposal/plan to tap sources of finance, other than the Central Government and State Government funds, to set up new institutions and to expand the existing institutions in education, especially higher education;
  - (d) if so, the details thereof; and
- (e) the number of universities, Central Universities, deemed institutions as on date, State-wise and category-wise?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI D. PURANDESWARI): (a) to (e) A Statement is laid on the Table of the House.

## Statement

(a) to (d) The approach paper on the Eleventh Five Year Plan States that "the role of the private sector in providing high quality education also needs to be recognized and a suitably facilitative environment created to allow such institutions to support our objectives of expanding higher education." The Eleventh Five Year Plan is yet to be finalized.

The National Knowledge Commission (NKC) in its "Note on Higher Education" has observed that "... private investment in university education, where more than 70 per cent students study, is almost negligible. It is essential to stimulate private investment in higher education as a means of extending educational opportunities."

The NKC recommendations are in the public domain for wider national debate, and are yet to be accepted by the Central Government.

However, according to the present policy, while participation of not - for - profit Societies, Charitable Trusts and Non-Governmental Organizations in the field of education is permissible, there can be no commercialisation of education, as pronounced by several judgments of the Supreme Court of India.

SHRI A. VIJAYARAGHAVAN: Sir, this matter is concerned .with the expansion of education and more investment in education in our country. Unfortunately, the reply does not mention in detail the aspect of more investment in education. Whenever there was a discussion on the investment in education, there was a hue and cry about more private investment that was going to come in. Unfortunately, that is not coming in. In the Eleventh Plan, according to the approach papers, we need to make an investment of more than 1.31 lakh crore of rupees in education. What is your approach? Are you going to make more investment through public sector or the Government's side? Are you going to invest more in education, especially, the higher education since 350 districts in this country do not have proper higher education facilities? What is the approach of the Government in this regard?

SHRIMATI D. PURANDESWARI: Sir, our commitment has always been to strengthen the higher education. With reference to the three hundred and odd Districts, which do not have proper higher educational facilities, I would like to say that it has been taken into consideration. Since Eleventh Plan is yet under formulation, we need to wait for it to be formalised completely. From the Government's side, we said that out of 30 new universities which would be coming up, 16 would be in such States which do not have Central University. It clearly speaks about our commitment towards it. Even in the answer to the question raised by the hon. Member, we have already said that the investment in education can be there if the societies, charitable trusts, non-profit organisations come forward. Definitely, there have been various judgements given by the hon. Supreme Court, which also emphasise that education cannot and should not be commercialised.

SHRI A. VIJAYARAGHAVAN: Sir, in the last part of the reply, the hon. Minister has clearly mentioned that various Supreme Court judgements are against commercialisation of education, that is, making money or profit through education. Unfortunately, this situation is quite different; it is *vice-versa*. Here, it has been totally commercialised, and, during the last four-five years, it has been

commercialised to a greater extent. In such a situation, we are facing serious problems. Sir, at the time of 93rd amendment, which was passed by this august House, the Government-ensured that new provisions would not be misused for privatisation or commercialisation. Similarly, with regard to the differential fee structure, which is prevalent in this country, I would like to say that the private colleges are charging even Rs. 3,30,000 as fee.

MR. CHAIRMAN: Question please.

SHRI A. VIJYARAGHAVAN: Sir, in such a situation, the Government has to come out with a comprehensive legislation. There are so many court verdicts that are contrary, and, the more talented and meritorious students are being kept out of the educational system. Will the Government come out with a comprehensive legislation in order to ensure that the poor students, meritorious students in this country get education? That is my question.

SHRIMATI D. PURANDESWARI: Sir, UGC is ...(Interruptions)...

SHRI A. VIJYARAGHAVAN: Not the *UGC...(Interruptions)...The* Government has to...(*Interruptions*)...

MR. CHAIRMAN: Let the question be answered. ...(Interruptions)...

SHRIMATI D. PURANDESWARI: Sir, the UGC is the competent body that can actually give regulations pertaining to the education. ...(*Interruptions*)...

SHRI A. VIJYARAGHAVAN: Sir, it is not the UGC..(Interruptions)... In this august House, there was an assurance. ...(Interruptions)...

MR. CHAIRMAN: Please, please. ...(*Interruptions*)... Let the question be answered. ...(*Interruptions*)...

SHRI A. VIJYARAGHAVAN: Sir, the Government has to ensure that the education. ...(Interruptions)... No profit-making...(Interruptions)... A comprehensive legislation is...(Interruptions)...
