- (a) whether Government provides Central Assistance for the implementation of Scheduled Caste Sub-Plan (SCSP);
 - (b) if so, the details thereof;
- (c) whether Government has formulated any plan to promote the economic wellbeing of Scheduled Caste women; and
 - (d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF SOCIAL JUSTICE AND EMPOWERMENT (SHRI RAMDAS ATHAWALE): (a) and (b) Yes, Sir. The Department of Social Justice & Empowerment is implementing a Centrally Sponsored Scheme of Special Central Assistance to Scheduled Castes Sub Plan (SCSP) since 1980 for the development of Scheduled Castes. Under the Scheme grant is given to State Governments/UT Administrations as an additive to their Scheduled Caste Sub Plan (SCSP) for income generating activities, infrastructure development and skill training.

- (c) and (d) Yes, Sir. The following special provisions have been made under the Scheme for SC women:
- In order to give necessary impetus for economic development of women, participation of at least 30% women candidates is to be ensured in the skill development programmes.
- (ii) States/UTs are also required to promote Scheduled Caste Women Cooperatives engaged in production and marketing of consumer goods and services.
- (iii) Focus has been given on viable income generating schemes/programmes exclusively for SC women.

THE MINISTER OF STATE IN THE MINISTRY OF SOCIAL JUSTICE AND EMPOWERMENT (SHRI RATTAN LAL KATARIA): (a) and (b) In order to provide for protection of rights of transgender persons and their welfare, the Ministry introduced a Bill titled "The Transgender Persons (Protection of Rights) Bill, 2019" in the Lok Sabha. The Bill was passed by the Lok Sabha on 05.08.2019 and by the Rajya Sabha on 26.11.2019.

The Ministry had released ₹ 1.00 Crore to National Backward Classes Finance and Development Corporation (NBCFDC) for conducting skill development training programme for the members of Transgender Community during financial year 2018-19.

Scholarships for SC students in private colleges
