**Encroachment in forest areas**

60. DR. SONAL MANSINGH: Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the steps taken by Government to increase the forest area in the country, State-wise;
- (b) the details of forest area prevailing in the country, State-wise;
- (c) whether Government is aware that some State Governments are allowing encroachments in the name of landless people, which causes a serious impact on climate change in the country; and
- (d) if so, the details thereof and action taken to evict the encroachers?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI BABUL SUPRIYO): (a) The Ministry is implementing various Centrally Sponsored Schemes such as National Afforestation Programme, National Mission for a Green India, Development of Wildlife Habitats etc. which contribute to increase in forest cover in the country. Besides, afforestation and other measures that contribute to increase in forest cover are undertaken using funds available under CAMPA and Externally Aided Projects. Afforestation activities are also taken up under Mahatma Gandhi National Rural Employment Guarantee Scheme, Pradhan Mantri Krishi Sinchayee Yojana and under various State/UT schemes/plans.

(b) The State/UT-wise details of forest cover and recorded forest area, as per India State of Forest Report 2019 are given in Statement (*See below*).

(c) and (d) The responsibility of forest protection including checking encroachments lies primarily with respective State/UT Governments. No information is available in the Ministry regarding State Governments allowing encroachments in the name of landless people.
