Proper Financing of Kharif and Rabi Loan to the Farmers of NE States

1929. SHRI W. ANGOU SINGH: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether Government are aware of the fact that the Kharif and Rabi loan to the farmers of the North East States are not properly financed for more production in this region; and
- (b) if so, the measures taken-up by Government for the farmers to meet the food sufficiency production in this region?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI SHRIPAD YESSO NAIK): (a) and (b) The Government is aware of inadequate flow of production credit in the North-Eastern Region (NER). Various measures taken by NABARD for improving the flow of production credit in the NER are as under:

- Minimum recovery norms for sanction of short-term credit limit have been relaxed.
- Norms in the discipline of Minimum Involvement of Internal Lendable resources of the banks for availing refinance for Short-Term (Seasonal Agricultural Operations) have been relaxed.
- Cooperative Banks operating in NER are charged interest at minimum rate i.e. 5.5% irrespective of their level of dependence on Short Term (Seasonal Agricultural Operations) refinance.
- Kisan Credit Card Scheme aimed at providing adequate and timely production credit support to the farmers from banking system has been launched.
