- (d) the number of ventilators that are being manufactured and the agency which has been assigned to manufacture these ventilators and the States that are going to be benefitted most?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI ASHWINI KUMAR CHOUBEY): (a) The details of number of ICU beds and Ventilators available and operational in different Government-run hospitals is not maintained Centrally. However, as per the information provided by the States/ UTs on the Covid-19 Portal, state-wise details of ICU beds and ventilators in COVID dedicated facilities. (Government and Private both) as on 14.09.2020 is at Statement-I (See below).

- (b) Ministry has instructed the States that required number of Ventilators for the States/UTs may be indicated so that the same can be supplied to States. So far, 32,109 Ventilators have been allocated to various States and a total of 20,916 Ventilators have been installed at the facilities. State wise particulars of allocation and installation of Ventilators as on 14.9.2020 is at Statement-II (See below).
- (c) Total amount of Rs 898.93 crores have been released from PM Cares Fund towards provision of ventilators.
- (d) Ministry of Health and Family Welfare had placed an order for supply, installation and commissioning of 30,000 ICU Ventilator from M/s Bharat Electronics
