The projects are identified for development in consultation with the State Governments/Union Territory Administrations and are sanctioned subject to availability of funds, submission to suitable detailed project reports, adherence to scheme guidelines and utilization of funds released earlier. Ministry of Tourism has sanctioned following projects for Maharashtra:-
