- (a) the ancient sites or monuments under the protection of the Central and the State Governments in North East India;
- (b) whether any special drive has been taken up by ASI in the last three years to identify ancient sites and monuments in North East India for declaration as of national importance;
 - (c) if so, the details thereof and if not the reasons therefor, and

(d) whether ASI has any plan to concentrate on major exploration in the northeast region to locate ancient sites and monuments for declaration as of national importance, in future?

THE MINISTER OF STATE OF THE MINISTRY OF CULTURE (SHRI PRAHALAD SINGH PATEL): (a) 83 monuments/sites in North-East are declared as of national importance under the Ancient Monuments and Archaeological Sites and Remains Act, 1958. As per information received there ares 281 monuments protected by State Governments in North-East India.

(b) to (d) Identification of new monument or site for central protection is a continuous phenomenon. Regular survey / exploration is carried out by Circle offices, Excavation Branches, Temple Survey Project, Building Survey Project and Prehistory Branch of Archaeological Survey of India. On identification of any protected monument, temple, building or archaeological sites, the same is recommended for Central protection by the Inspecting Office. As on date Badarpur Fort, District Karimganjj Assam has been identified for declaration as of National importance under the Ancient Monuments and Archaeological Sites and Remains Act, 1958 Further, Sibsagar in Assam is one of the iconic site identified for development and onsite Museum.

Speedy clearance for film shoots at monuments

The applicant uploads the details on the Archaeological Survey of India (ASI) portal along with necessary documents. Once the application is received, it is processed immediately and permission is issued within the shortest possible time. In addition to this ASI's online application system has been integrated with the Ministry of Information and Broadcasting and National Film Development Corporation (NFDC)'s Film Facilitation
