The establishment of IISER was highly envisaged by many scientists as the road to broaden the scope of education in basic science amongst the young brilliant minds of the country.

This is a well-known fact that the development in all aspects in the entire North Eastern States is comparatively lagging far behind. So far, seven IISERs have been established in the entire country with an exception of North Eastern Region of India.
