**Need to fill up the vacant faculty posts in premier educational institutions**

According to recent report of the HRD Ministry, approximately 38 per cent faculty posts are lying vacant at India's premier institutions like IITs, NITs, IIMs and IISERs. As a consequence of such shortage of faculty, quality of education in these premier institutes is gradually degrading which is against the national interest. Therefore, through this august House, I urge that urgent and suitable directions may please be issued to the Government of India to take necessary and appropriate steps to initiate the process of filling up these vacancies at the earliest.
