# Need to fill up the vacant faculty posts in premier educational institutions

SHRIMATI PRIYANKA CHATURVEDI (Maharashtra): Sir, it is a matter of concern. According to recent report of the HRD Ministry, approximately 38 per cent faculty posts are lying vacant at India's premier institutions like IITs, NITs, IIMs and IISERs. As a consequence of such shortage of faculty, quality of education in these premier institutes is gradually degrading which is against the national interest. Therefore, through this august House, I urge that urgent and suitable directions may please be issued to the Government of India to take necessary and appropriate steps to initiate the process of filling up these vacancies at the earliest. Thank you, Sir.

DR. AMAR PATNAIK (Odisha): Sir, I associate myself with the matter raised by the hon. Member.

PROF. MANOJ KUMAR JHA (Bihar): Sir, I also associate myself with the matter raised by the hon. Member.

MR. CHAIRMAN: Members should note that if they have given notice and I have already admitted one in a week, priority will be given to the Member who has not got even one chance in that week. If I find time, then I will call them also. Prima facie, every Member should get an opportunity depending on the importance of the issue that is being raised. This has to be kept in mind.
