

**Demand for intervention to make the Pradhan Mantri Jan Aushidhi Yojna successful
in Jharkhand**

Demand to declare Kangla, the ancient capital of Manipur as the world Heritage site

SHRI MAHARAJA SANAJAOBA LEISHEMBA (Manipur): Sir, Kangla - the ancient capital of Manipur had been the seat of Manipur civilisation since time immemorial, till the British occupation of Manipur on 27th April, 1891 A.D. More than 70 kings of same Dynasty ruled continuously for 1858 years at Kangla.

British officers in Manipur described in their books/reports about many fine buildings and monuments of Kangla. However, they destroyed everything after the Anglo-Manipuri war of 1891 A.D.

It is also a well known fact that Manipur gave the game of modern polo to the world. The Britishers called the game as "Hockey on Horse-back" and Lord Curzon, the then Viceroy of India, described Manipur as "Cradle of Polo". Since the modern polo has originated from Manipur, the oldest polo ground of the world is the polo ground of Kangla, Manipur.

Therefore, I request the Government through this House to take steps to get Kangla declared as the world heritage site.

**Demand to release funds for construction of Steel Superstructure Bridge over the
River Pachin in Arunachal Pradesh**

SHRI NABAM REBIA (Arunachal Pradesh): Sir, I would like to draw the attention of the hon. Minister of Railways towards construction of steel superstructure bridge over river Pachin to connect Naharlagun Railway Station from National Highway 415 via Lekhi village in Arunachal Pradesh. The project was approved in 2016 and the foundation work was commenced in the same year. Later, due to funds crunch, the

project could not be completed. This is an important bridge which minimizes traffic problem of twin capital city Naharlagun (Itanagar) by shortening the road length by about 14 kms. I had brought this matter to the notice of hon. Minister of Railways.

Keeping in view of the importance of the bridge and problems being faced by the people of twin capital city, Naharlagun (Itanagar), I urge upon the Government of India to consider this matter for release of necessary funds in the present Budget for its early completion. Thank you.

Demand to remove encroachment of land of the University of Hyderabad

SHRI ELAMARAM KAREEM (Kerala): Sir, I would like to draw the attention of the House towards the forceful encroachment of large acres of land of the University of Hyderabad, East Campus, by many private and public entities. University of Hyderabad was established by an Act of Parliament in 1974 on the lines of point number two of the 'Six-point Formula of 1973' after the historic movement led by the people of Telangana, and it was allotted 2300 acres of land for academic purpose. It is one of India's most reputed central universities and is also an 'institute of eminence'. The university's geographical location and particularly of this specific part of the campus, which is now being encroached, is very crucial and is known for its biodiversity. For the last several years, many private and public entities have been trying to occupy the university land through several ill-tactics. However, a large part of the university land is already given to many institutions. Students and other stakeholders of the university have been continuously resisting this illegal encroachment. I appeal to the Government to urgently intervene and end the illegal and forceful encroachment of one of our premier educational institution's land. Also, the existing land's mutation should be done in favour of the University.
