Demand to connect delhi-vadodara express highway through an approachable road to a sacred place of tribals near district dausa, rajasthan

डा. किरोड़ी लाल मीणा (राजस्थान): माननीय सभापति जी, राजस्थान के जिला दौसा में National Highway 11A के KM 16.5/00 पर आदिवासियों का एक बहुत बड़ा पवित्र स्थल है, जिसके करीबन 2.5 किमी दूरी से दिल्ली-बड़ोदरा एक्सप्रेसवे गुजर रहा है। राज्य में निवास करने वाले करीबन 13.5 प्रतिशत आदिवासियों की माँग है कि उक्त स्थल को दिल्ली-बड़ोदरा एक्सप्रेसवे के KM 199/00 के पास clover leaf बना कर व्यापक जनहित में इस स्थान को जोड़ा जाना चाहिए। इस सम्बन्ध में माननीय मंत्री, भूतल एवं परिवहन विभाग तथा NHA के अधिकारियों को कई बार ज्ञापन देकर माँग की जा चुकी है। इस सम्बन्ध में NHA के PD, दौसा द्वारा एक पत्र क्रमांक 23011/21/पकाई/दौसा/भारतमाला/VIP Ref./Clover leaf/7770 दिनांक 02.03.2021, NHA के उच्चाधिकारियों को लिखा गया है। आदिवासियों के सबसे बड़े स्थान के महत्व को दृष्टिगत रखते हुए पैकेज नं. 7 के चैनल संख्या 199.817 पर एक माइनर ब्रिज का निर्माण किया जा चुका है। IRC:92:2017 के अनुसार उक्त स्थान पर clover leaf निर्माण हेतु लगभग 7.30 हेक्टेयर भूमि वांछनीय है। इस भूमि की आवाप्ति की आवश्यकता इसलिए नहीं है कि सम्पूर्ण भूमि सरकारी भूमि है, इस स्थान पर clover leaf बनाये जाने हेतु करीबन 50-60 करोड़ रुपये की आवश्यकता होगी। उक्त महत्वपूर्ण कार्य हेतु change of scope वांछनीय है। अतः उक्त स्थान पर एक अप्रोच रोड के जरिए दिल्ली-बड़ोदरा एक्सप्रेसवे से आदिवासी स्थल को जोड़ा जाये।

Demand for the establishment of AIIMS in Sundargarh, Odisha

DR. AMAR PATNAIK (Odisha): Sir, the Odisha Government has proposed to the Centre to set up an AIIMS in Sundargarh district. Since a second AIIMS has already been established in Bihar and a similar proposal is under consideration in another State, it is proposed that a second AIIMS may be considered at Sundargarh. The second largest district of the State, Sundargarh is a tribal dominated district with 50.7 per cent tribal population, the second highest tribal population district in the State.

Scheduled Castes also constitute a large proportion of the district population and have reported much higher incidence of poverty. The majority of farmers are marginal farmers with average operational holding of 0.59 hectare. Thus, establishing a second All India Institute of Medical Sciences at Sundargarh would cater to this vulnerable population and help in providing quality tertiary care in the backward areas of entire western Odisha. The institution of national repute will also promote medical education in the area. Further, the infrastructure available at Sundargarh can be utilised for setting up of AIIMS, and the Centre may not immediately have to invest on infrastructure. As part of a CSR initiative, an MoU has already been signed between the Odisha Government and NTPC to establish a medical college and hospital. The construction of the project has been completed and the equipment procurement process is underway. The hospital is designed for 500 beds and the college will be adequate enough to have 100 MBBS students. Additionally, the location will be suitable for setting up AIIMS as it is easily accessible through road, railways and air. Therefore, I demand establishment of AIIMS in Sundargarh in Odisha. Thank you, Sir.
