ALI ASHRAF FATMI): (a) to (c) Based on District Information System for Education (DISE) data 2005-06 published by National University of Educational Planning and Administration (NUEPA), for elementary education level, there are about 32,000 schools without enrolment, as many listed private schools have not reported their enrolment data, in some cases, there is a duplication of school listings, etc.; there are over 2 lakh schools with enrolment between 1-50 students, as several areas in the country have low population density.

The funding provided for the purpose is as per the Centre State sharing pattern under the SSA. The SSA is committed to construction of five lakh classrooms and appointment of 1.50 lakh teachers in 2007-08.

National Board of Sanskrit School Education

There has been no change in the established procedure of selection of the Director. The Chairman of the Board of Governors (BoG) of the concerned Indian Institute of Management is invariably a member of Search-cum-election Committee.
