- (a):** During the last three years, the Foreign Direct Investment (FDI) equity inflow increased from US\$ 44,857 million in 2017-18 to US\$ 49,977 million in 2019-20, registering a growth of 11%.
- (b)&(c):** Sector wise details of FDI equity inflow reported in the last three years and the current year are at Annexure-I.
