National policy regarding agricultural pension to old farmers

Old Age Pension Scheme and Annapurna Scheme for the welfare of all old persons including farmers. In view of the above, no new scheme is visualised for the welfare of old farmers at present.

Assistance for relief and rehabilitation programme in the cyclone affected districts of Orissa

- (a) the amount of central assistance sanctioned and released so far for implementing the relief and rehabilitation programme in the cyclone affected districts in Orissa since October, 1999;

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI SHRIPAD YESSO NAIK): (a) During 1999-2000, Central share of Calamity Relief Fund (CRF) amounting to Rs. 42.50 crore was released to Orissa for undertaking immediate relief measures in the wake of natural calamities. In addition, Rs. 828.15 crore from the National Fund for Calamity Relief (NFCR) was released to the State for floods and 2 cyclones, including the Super cyclone.

(b) to (d) The World Bank has approved US \$ 46 million for the immediate phase of the Orissa cyclone project through an amendment to the Orissa Water Resources Consolidation Project. The amendment is yet to be signed and no funds have, therefore, yet been obtained from the World Bank for this purpose.
