- (c) the details of total number and type of machines delivered to farmers in 2019 and 2020, State-wise; and
- (d) the reasons for discrepancy, if any, between the planned amount and the delivered amounts for each year mentioned above, State-wise?

(a) to (d);: The Central Sector Scheme on 'Promotion of Agricultural Mechanization for In-Situ Management of Crop Residue in the States of Punjab, Haryana, Uttar Pradesh and NCT of Delhi' is being implemented through the State Governments. Based on the Annual Action Plans submitted by the States at the beginning of each financial year, the funds are released to the State Governments for extending financial support @ 50% of the cost for purchase of machines by the individual farmers and @80% of the project cost to the Co-operative Societies of farmers, Farmers Producer Organizations (FPOs), Registered Farmers Societies and Panchayats for establishment of Custom Hiring Centres (CHCs) of crop residue management machinery identified for promotion under the scheme. Based on the information furnished by the State Governments, the details are enclosed in **Annexure-I**

The variation in number of machines targeted and actual delivery is due to the reasons that machines have been delivered as per actual demand of the farmers & CHCs as per their choice of machine in the season
