INDUSTRIAL CORRIDORS IN THE COUNTRY

1348. Shri Satish Chandra Dubey:

Will the Minister of Commerce and Industry be pleased to state:

- (a) whether Government is developing Industrial Corridors in the country;
- (b) if so, the details of proposed developmental activities thereof, State-wise;
- (c) the role of State and Central Governments in the development of the said Industrial Corridors; and
- (d) the details of amount allocated, released and spent on the development of the said Corridors, especially in Bihar?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE & INDUSTRY (SHRI SOM PARKASH)

- (a)&(b): Government of India is developing various Industrial Corridor Projects as part of National Industrial Corridor programme which is aimed at development of greenfield industrial smart cities which can compete with the best manufacturing and investment destinations in the world. Government of India has accorded approval for development of 11 corridors (32 projects) in four phases as part of National Master Plan for providing multi-modal connectivity to economic zones which are under various stages of conceptualization/development/implementation. The list of projects in the respective states along with status of implementation is attached at **Annexure**.
- (c)&(d): As per approved Financial and Institutional Framework of Industrial Corridors Programme, State Governments provide land while the Central Government through National Industrial Corridor Development and Implementation Trust (NICDIT) provides funding support as matching equity for creation of trunk infrastructure. The details of funds are as follows:

Amritsar-Kolkata Industrial Corridor (AKIC) covers the state of Bihar. Government of Bihar has identified a site for setting up Integrated Manufacturing Cluster (IMC) at Gamhariya in Gaya District as a part of AKIC. Conformation of land details including boundaries is awaited from State Government. Therefore, no funds have been allocated and released to the project in the State of Bihar as yet.
