- (a) whether Government has taken any special initiatives to ensure industrialisation in the tribal/backward areas of Tamil Nadu by setting up of industry for economic development and generation of employment in the State;
- (b) if so, the details thereof;
- (c) whether any other steps have been taken by Government to increase trade in the State of Tamil Nadu; and
- (d) if so, the funds allocated/ released and utilised during the last three years and the current year?

(SHRI SOM PARKASH)**

(a)&(b): Government of India (GoI) is developing various Industrial Corridor Projects as part of National Industrial Corridor Programme which is aimed at development of greenfield industrial cities, providing plug n play infrastructure, increasing employment opportunities, providing better facilities for the new and growing workforce and expanding industrial output. Government of Tamil Nadu has identified Ponneri node under Chennai Bengaluru Industrial Corridor (CBIC), and Dharmapuri node under extension of CBIC to Kochi via Coimbatore for development. Consultants have been appointed for master planning, market demand assessment and preliminary design for these two nodes. Under the Industrial Infrastructure up-gradation Scheme (IIUS)/Modified IIUS (MIIUS) which is aimed to provide quality infrastructure in selected functional clusters/locations which have the potential to become globally competitive, projects were sanctioned in the state of Tamil Nadu. The details of these seven projects are at **Annexure – A**.

(c)&(d): Under Trade Infrastructure for Export Scheme (TIES), financial support has been extended for the State of Tamil Nadu by Department of Commerce, Government of India. The details are at **Annexure – B**.
