- (b) if so, the list of commodities where exports suffered highly?

(a) & (b): India's merchandise export was US\$ 201.30 billion during 2020-21 (April-December) while it was US\$ 238.27 billion during 2019-20 (April-December). The details of exports for first three quarters along with the percentage change over the corresponding quarters of the previous year are given below:
