various associations in the textiles industry seeking relief including reimbursement of State and local land duties, on account of the appreciation of the rupee.

(c) Government has announced an export package comprising several relief measures, including revision. in the Duty Drawback and DEPB rates, which will benefit the textiles sector. DEPB rates have been enhanced by 3% for nine sectors which include Textiles (including handlooms), readymade garments, and handicrafts. In addition, the premium on export credit guarantee has been reduced by ten per cent, the rates of duty drawback have been enhanced, and the rate of interest on pre-shipment and, post-shipment credit has been reduced by two per cent.

- (d) whether Kendriya Vidyalaya, INA Colony has taken up any such quality assessment of its students for class VIII;
  - (e) if so, the results thereof; and
  - (f) if not, by when the Kendriya Vidyalaya Sangathan intends to initiate it?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) No, Sir. However, Kendriya Vidyalaya Sangathan (KVS) had conducted a sample survey of learners achievement for pass out students of Class-V of Kendriya Vidyalayas (KVs) in April 2006 with standardized question papers in Mathematics, English and Environmental Studies.

- (b) Does not arise.
- (c) The assessment of students in all classes including VII and VIII of KVs is done regularly through unit tests, half-yearly and end of session examinations.
  - (d) No, Sir.
  - (e) Does not arise.
- (f) The assessment of students for all classes including class VIII is done in KV, INA Colony regularly through unit tests, half-yearly and end of session examinations.

## Power to all by 2012

- \*202. SHRI RAJKUMAR DHOOT: Will the Minister of POWER be pleased to state:
- (a) whether it is a fact that Government are planning to provide power to all by 2012:
- (b) if so, what is the estimate of total power requirement of each State and UT in 2012, the sources of supply and their capacities to provide power;
- (c) what directions have been given to State Electricity Boards and power distributing agencies to ensure that transmission lines are ready in time to supply power available for consumers; and
- (d) the authority designated to co-ordinate for ensuring planned construction and commencement of productions, distribution of power to distributing agencies and transmission to consumers?

THE MINISTER OF POWER (SHRI SUSHILKUMAR SHINDE): (a) and (b) Yes, Sir. The National Electricity Policy notified on 12th Feb. 2005 envisages that demand for power is to be fully met by 2012.

As per the 17th Electric Power Survey of India, the forecast of electricity demand in terms of electrical energy requirement and peak electric load for the year 2011-12 has been assessed as 968 Billion Units and 1,52,746 MW respectively. The State wise details are given at Statement-I (See below).

To meet the demand, a capacity addition of 78,577 MW (as per State-wise details given in Statement-II (See below), has been proposed for the Eleventh Plan.
