Scholarship for differently-abled students

306. SHRI MANAS RANJAN BHUNIA:

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

(a) the number of differently-abled students who have been covered under various scholarship schemes during the last three years by Government, State-wise and year-wise details thereof;

(b) the State-wise number of differently-abled students in the country;

(c) whether Government is satisfied with the coverage of differently-abled students under the said schemes; and

(d) if not, the steps taken and yet to be taken to provide scholarships to all differently-abled students ?

ANSWER

MINISTER OF STATE FOR SOCIAL JUSTICE & EMPOWERMENT (SHRI KRISHAN PAL GURJAR)

(a) Under the Scholarship Schemes for Students with Disabilities, students with benchmark disability (disability of 40% or more) are eligible for scholarship. State-wise and year-wise number of differently-abled students who have been covered under various scholarship schemes during the last three years is at **Annexure**.

(b) The Ministry does not compile information relating to Students with Disabilities. However, as per Census 2011, there are 2.68 crores Persons with Disabilities in the country.

(c) & (d) The number of Students with Disabilities getting scholarship has increased from 306 during 2014-15 to 42972 during 2019-20. With a view to ensure better coverage of these schemes the Ministry has taken the following measures:-

(i) Until 2017-18, these six scholarship schemes, viz, Pre-matric, Post-matric, Top Class Education, National Fellowship, National Overseas and Free Coaching were implemented as stand-alone schemes having separate budgets. From Ist April, 2018, all the six scholarship schemes have been merged into an Umbrella Scheme titled 'Scholarship for Students with Disabilities' and have been registered in PFMS portal with a unique code for direct benefit transfer. The merger/unification of the schemes with effect from 2018-19 has been done to remove the demand-supply imbalance caused by budget allocation and streamline the implementation process. In the umbrella scheme, if there is surplus fund available in one segment that can be utilized in the other segment.

(ii) The Department issues advertisements in leading Newspapers across the country to increase awareness of these schemes amongst students and other stakeholders. All the other types of media are also tapped for spreading awareness.

(iii) Under the revised scheme implemented with effect from 01.4.2018, the amount of Pre & Post Matric Scholarship has been increased. Also the number of slots in Pre- Matric scholarship has been increased from 20,000 to 25,000 and in case of Top Class Education Scholarship scheme from 160 to 300.

(iv) Under National Overseas Scholarship, the applications can be made throughout the year.
