**BOOSTING STEEL PRODUCTION IN LIGHT OF COVID-19  
LOCKDOWN**

314. SHRI ANAND SHARMA:

Will the Minister of Steel be pleased to state:

- (a) whether output of steel contracted between March, 2020 and 31 December, 2020;
- (b) if so, the details thereof, month-wise during the period;
- (c) whether Government has taken measures to boost steel production in light of the COVID-19 lockdown and consequent decline in manufacturing activity in 2020-21; and
- (d) if so, the details thereof?

**ANSWER**

(a)&(b): The details of month wise crude steel production during the period March-December, 2020 are as following:-

(c)&(d): The measures taken by the Government to boost steel production in light of the COVID-19 lockdown are as following:-

- (i) Ministry of Steel has held several rounds of consultations during the lockdown period with various stakeholders including industry associations and leaders of domestic steel industry to address their issues by taking up the same with the concerned Ministries/Departments of the Central Government and State Governments. Ministry of Steel also notified a nodal officer in the Ministry to receive representations from the steel industry on issues arising out of lock down for speedy redressal. Guidelines issued by the Ministry of Home Affairs from time to time have facilitated speedy resumption of steel production. The Ministry of Steel has also organized the following Webinars with relevant stakeholders to enhance the overall demand for steel in the country:-
  - (a) Oil and Gas Sector, 16<sup>th</sup> June, 2020.
  - (b) Ispati Irada, Enhancing Steel Usage, 30<sup>th</sup> June, 2020.
  - (c) Housing and Civil Aviation Sector, 18<sup>th</sup> August, 2020.
  - (d) Agriculture, Rural Development, Dairying and Food Processing Sectors, 20<sup>th</sup> October 2020.
  
- (ii) Domestically Manufactured Iron & Steel Products (DMI&SP) Policy, has been suitably amended vide notification dated 31<sup>st</sup> December, 2020, in order to align it to the revised Public Procurement (Preference to Make in India) Order 2017. The minimum value addition has been enhanced from 15% to 20% and the policy is now applicable to all procurement above Rupees 5 lakhs and includes EPC contracts among other changes.
