Artificial limb manufacturing

2547. Shri Sanjay Seth: Shri Rajeev Satav:

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) whether Artificial Limbs Manufacturing Corporation of India (ALIMCO) is supplying artificial limbs, if so, whether Government has achieved the objective for which ALIMCO was set up;
- (b) whether the corporation has adopted any cost reduction measures to optimize cost of production without sacrificing the quality standard of its products, if so, the details thereof;
- (c) the measures being taken to ensure the supply of such equipments as per the demand; and
- (d) the details of camps organized to provide supporting equipments during the said period, State-wise alongwith the number of persons who got the benefit?.

ANSWER

MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT

SHRI KRISHAN PAL GURJAR

(a) Yes, Sir. Artificial Limbs Manufacturing Corporation of India (ALIMCO) started manufacturing and supplying various types of aids & assistive devices, including artificial limbs in 1976. The main objectives of the Corporation are to provide better quality of aids & appliances to large number of persons with disabilities at reasonable prices across the country. Due to the gradual increase in its operations, it has five Auxiliary Production Centres (AAPCs) situated at Bhubaneswar(Odisha), Jabalpur(M.P), Bengaluru(Karnataka), Mohali(Punjab) and Ujjain(MP). The Corporation has five Marketing Centres at New Delhi, Kolkata, Mumbai, Hyderabad and Guwahati.

The details of production of aids & assistive devices by ALIMCO during the last five years are at Annexure-I.

- **(b)** The corporation has adopted various measures to optimize the cost of production without sacrificing the quality of its products. These include:
- Widening the supplier base, thereby inducing competition for better quality products at reasonable prices.
- 2. Improving & improvising the design of parts & assemblies.

The modernisation project of the corporation is in progress. On completion of the modernisation project, welding and assembly processes will be done through state- of- the- art machines/ equipment. This will help the Corporation in achieving high quality of products and reducing the cost of production due to increased efficiency & productivity.

- (c) The Corporation has taken the following measures to ensure supply of such equipment as per their demand:
 - a. A robust system is being followed for booking of orders/follow up and ensuring timely supplies by maintaining electronic data of all the dispatches.
 - b. Use of closed body containers is being adopted to ensure speedy & safe delivery of materials at respective destinations for distribution of aids and assistive devices.
- (d) The details of camps conducted and number of beneficiaries covered during the last three years under Assistance to Disabled Persons for Purchase/Fitting of Aids and Appliances (ADIP)' Scheme and Rashtriya Vayoshri Yojana(RVY) are at Annexure-II & Annexure-III.
