**Web-based programme for UDID cards**

**1910. SHRI RAJEEV SATAV:  
SHRI SANJAY SETH:**

Will the Minister of **Social Justice and Empowerment** be pleased to state:

- (a) whether Government has started issuing Unique Disability Identity (UDID) cards to each person with disability in the country through uniform web-based programme and if so, the details thereof;
- (b) whether only few States have been covered in the first phase of issuing identity cards if so, the reasons therefor and the time by which other States will also be covered;
- (c) whether specific guidelines issued relating to Persons with Disabilities (PWDs) during the lockdown period; and
- (d) if so, these guidelines whether made available in braille, audio format, sign language or other accessible formats and if not, the reasons therefor?

**ANSWER**

**(SHRI KRISHANPAL GURJAR)**

(a) Yes, Sir The Department of Empowerment of Persons with Disabilities is implementing the Unique Disability Identification (UDID) Project with a view to create a national data base for Persons with Disabilities (PwDs) and to issue unique disability ID cards to PwDs. The UDID project provides an online platform ([www.swavlambancard.gov.in](http://www.swavlambancard.gov.in)) for issuance of disability certificates as well UDID cards.

All States/UTs in the country have started generating UDID cards to the Persons with Disabilities (PwDs). As on 04.03.2021, 54.25 lakh UDID cards have been generated in all States/UTs.

The details of the UDID cards generated States/UTs- wise are at Annexure.

(b) No, sir. All States/UTs have to issue UDID cards since the commencement of the project.

(c) and (d) On 26.03.2020, the Department of Empowerment of Persons with Disabilities issued 'Comprehensive Disability Inclusive Guidelines for protection and safety of persons with disabilities (Divyangjan) during COVID 19' to all States/UTs. These guidelines are available in accessible audio format for persons with visual impairments, which are available on the website of National Institute of Empowerment of Persons with Visual Disabilities. Further, Indian Sign Language Research and Training Centre (ISLRTC) has developed accessible Sign Language format of these guidelines which are available on its website. Braille version of the document was not produced for mass level dissemination to avoid physical contact during pandemic.
