IMPORTS DURING COVID-19

1983. SHRI TIRUCHI SIVA:

Will the Minister of **COMMERCE &INDUSTRY** be pleased to state:

- (a) whether there has been a reduction in imports from China in 2020-21, if so, of which products and is India self-sufficient in these; and
- (b) whether there has been a reduction in imports from other nations due to Coronavirus pandemic, if so, the list of nations?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI HARDEEP SINGH PURI)

- (a): During April-December 2020-21, India's total imports from China P Rp was US\$ 45.37 billion as compared to US\$ 51.91 billion during the same period of previous year, showing a reduction of 12.61%. The details of products for which the imports from China P Rp have been reduced during 2020-21 (April-December) are at **Annexure-I**. Imports take place to meet the gap between domestic production and supply, consumer demand and preferences for various items. The Government has taken several steps to create/enhance of domestic capacity, incentivizing domestic manufacturing through Production Linked Incentive Schemes, phased manufacturing plans, purchase preference, timely use of trade remedy options, adoption of mandatory technical standards, enforcement of FTA Rules of Origin (RoO) and development of import monitoring system.
- **(b):** The details of major countries from where imports have reduced during 2020-21 (April-December) are at **Annexure-II.**
