#### 'PADHO PARDESH' AND SCHOLARSHIP SCHEME FOR MINORITIES

#### 2201. SHRI SUJEET KUMAR:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) the details of implementation of 'Padho Pardesh', a scheme that provides interest subsidy to minority students for overseas studies, State-wise;
- (b) the number of students who have benefitted from this scheme in the State of Odisha; and
- (c) the details of the implementation of pre-matric, post-matric and merit-cum-means scholarship schemes for minorities, State-wise?

# ANSWER MINISTER OF MINORITY AFFAIRS (SHRI MUKHTAR ABBAS NAQVI)

- (a) & (b): The Ministry of Minority Affairs implements 'Padho Pardesh- Scheme of Interest Subsidy on Educational Loans for overseas studies for the educational empowerment of students belonging to six notified minority communities i.e. Buddhist, Christian, Jain, Muslim, Parsi and Sikh in all States across the country including the State of Odisha. Under the scheme, the interest subsidy is awarded to students on the interest payable for the period of moratorium against the education loans taken for overseas studies to pursue approved courses at Masters, M.Phil or Ph.D levels. The State/UT-wise details of interest subsidies sanctioned to the minority students including State of Odisha during the years 2014-15 to 2019-20 are annexed.
- (c): This Ministry also implements Pre-Matric, Post Matric and Merit-cum-Means based Scholarship Schemes for the educational empowerment of students belonging to six notified minority communities i.e. Buddhist, Christian, Jain, Muslim, Parsi and Sikh in all States throughout the country. The State/UT-wise details of scholarships sanctioned during the years 2014-15 to 2019-20 are **annexed**.
