Will the Minister of Youth Affairs and Sports be pleased to state:

- (a) the details of amount of funds that could not be spent under the various schemes of the Ministry during the last year due to COVID-19, scheme-wise;
- (b) whether the development of the areas for which the schemes were introduced has been hampered due to no expenditure on development, maintenance and promotion of the schemes; and
- (c) if so, the details of steps being taken more swiftly on the schemes to compensate for the same?

(a) to (c) Scheme-wise details of funds allocated at Budget Estimate (BE), Revised Estimate (RE) and actual expenditure as on 10.3.2021 for the financial year 2020-21 are given at Annexure.

It is a fact that due to COVID-19 pandemic which resulted in lockdown across the country and imposing of restrictions on gatherings, etc, conduct of programmes, sports

coaching / training programmes, conduction of national championships and international tournaments / events in India, participation of sportspersons in national and international sports tournament and other activities / programmes of the Ministry requiring gatherings were affected during this period of the lockdown. Also, development of areas for which schemes were introduced was hampered for a temporary period due to non-expenditure and curtailment of budgetary allocations. However, with the lifting of restrictions, training / coaching of sportspersons, conduction of national and international tournaments, participation in sports competitions and other activities and programmes of the Ministry have been resumed as per the Standard Operating Procedures (SOP) issued by the Ministry of Health and Family Welfare, Ministry of Home Affairs and Ministry of Youth Affairs and Sports.
