Foreign aid for Sarva Shiksha Abhiyan

1537. SHRI BALWANT ALIAS BAL APTE: SHRI VINAY KATIYAR:

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether Government have been receiving foreign aid during the current year for Sarva Shiksha Abhiyan (SSA);
- (b) if so, the total amount of foreign aid received for the SSA and the District Primary Education Programme (DPEP) during the last two years, programme-wise;
 - (c) whether the said amount is being spent on SSA and DPEP; and
- (d) the total amount of foreign assistance spent, so far, on the said programmes alongwith the balance amount yet to be spent thereon?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI ASHRAF FATMI): (a) to (d) The Government of India (GoI) had tied up external funding for Sarva Shiksha Abhiyan (SSA) with the World Bank, Department For International Development (DFID) of United Kingdom (UK) and European Commission for the period 2004-07 amounting to about Rs. 4700 Crore. External funds are availed of by the Government as reimbursement against expenditures incurred in SSA. The entire amount due, has been reimbursed from the external funding agencies towards the SSA.

Under the District Primary Education Programme (DPEP) there are only two ongoing programmes, 8 districts in Orissa and 9 districts in Rajasthan, where the DFID of UK and the World Bank respectively, are the external funding agencies. Rs. 553.97 crore in 2005-06 and Rs. 126.31 crore in 2006-07, have been received as reimbursement under DPEP.

Promotion of students in classes VI to VIII

English as stumbling block for students

- (a) whether it is a fact that according to the National Commission for Minority Educational Institutions (NCMEI), English remains a stumbling block for thousands of students:
 - (b) if so, the details thereof;
 - (c) the reasons therefor;
- (d) whether Government are seriously deliberating to prepare the students to overcome this problem and to go ahead in studies with brimming confidence; and
 - (e) if so, the steps taken/to be taken in this direction?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI ASHRAF FATMI): (a) to (c) The National Commission of Minority Educational Institutions (NCMEI) has not expressed its opinion regarding English being stumbling block for the thousand of students.

(d) and (e) As per CBSE scheme students have to study two languages of which one will be Hindi or English. Hence, students who are not proficient in English have option to opt for Hindi or any other language provided in the currculum. However, CBSE provides two courses in English at secondary level and three courses at senior secondary level, students can choose any of these courses as per their needs and level of competence in the language.

CBSE Scheme of Studies has adequate inbuilt flexibility to cater to the differing and diverse needs of the students. The Board also brings out student support materials such as sample question papers and marking scheme in all major languages including English and other subjects to help students prepare effectively for the examination. Counselling before public examinations is provided by the Board to improve the self confidence of students and to clear their doubts so that they can write the examination confidently. The Board also conducts teacher training programme to equip the teachers with the needed professional skills and knowledge so that they are able to prepare the students effectively.
