Will the Minister of Planning be pleased to state:

- (a) Whether Government has identified any backward districts in the States for developing education, healthcare and infrastructure related facilities under the “Aspirational Districts Programme”;
- (b) If so, the details thereof;
- (c) the number of districts identified and the funds sanctioned and released for the same; and
- (d) the details of work started in these districts and the progress made there so far?

- (a) Yes, under the Aspirational Districts Programme, 112 districts, across 26 states and 1 Union Territory, based on a Composite Index of Backwardness. These districts had shown relatively less progress in the socio-economic parameters. List of data sets and the weight attached to them for selection of these districts is attached in *Annexure - I*.
- (b) The State-wise list of all 112 Aspirational Districts is attached as *Annexure - II*.
- (c) Districts become eligible for additional allocation on the basis of performance in the overall development or in the sectors like Health and Nutrition, Education, Agriculture and Water Resources, Financial Inclusion and Skill Development and Basic Infrastructure. These sectors are under focus in the programme. On a monthly basis, the best performing district receives additional allocation upto Rs. 10 Cr, the second-best performing district receives Rs. 5 Cr and districts performing well in different sectors like health, education, agriculture receive Rs. 3 Cr each. These funds are sanctioned and released after the plan of action are submitted by the districts for the utilization of funds. List of districts which have become eligible and funds sanctioned is attached as *Annexure - III*.

- (d) The projects are undertaken by the districts as per the extant rules of the state government concerned. The sanctioned projects under each theme are as follows:
