Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the total number of affordable houses constructed under the Pradhan Mantri Awas Yojana (Urban) (PMAY)(U) for the benefit of urban poor during each of the last three years particularly in Karnataka, State-wise;
- (b) whether Government has any time frame for completion of the yojana and if so, the details thereof;
- (c) the new targets fixed under the yojana for the next three years, year/State-wise; and
- (d) the proposed action plan to achieve the desired targets?

- (a) State/UT-wise details of affordable houses constructed for the benefit of urban poor in the country (including Karnataka) under Pradhan Mantri Awas Yojana (Urban) [PMAY(U)] during last three years are at Annexure.
- (b) to (d) Construction of houses under PMAY(U) requires adherence to project cycle as per Detailed Project Reports (DPRs) submitted by the State/UT-Governments while seeking central assistance. All the sanctioned houses are to be completed within the scheme period, i.e. by the year 2022 and as such, no new targets for the next three years have been fixed.
