PAISA PORTAL UNDER DAY-NULM

NO. 2468. SHRI AYODHYA RAMI REDDY:

Will the Minister of Housing and Urban Affairs be pleased to state:

- (a) the details of progress made with respect to the Portal for Affordable credit and Interest Subvention Access (PAiSA) established under Deen Dayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM);
- (b) the city-wise details thereof;
- (c) whether Government intends to introduce further steps to reduce poverty in the urban areas of the country; and
- (d) if so, the details thereof and if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI HARDEEP SINGH PURI)

(a)&(b): Ministry of Housing and Urban Affairs has launched a Portal for Affordable Credit and Interest Subvention Access (PAiSA), on November 26, 2018 for online credit of interest subvention to individuals/ groups/ Self Help Groups who have availed bank loans for setting up self-employment ventures under Self Employment Programme (SEP) component of the "Deendayal Antyodaya Yojana- National Urban Livelihoods Mission (DAY-NULM)". The Portal aggregates Banks, States and Urban Local Bodies (ULBs) on a single platform, facilitating real time exchange of information, and provides a simple mechanism to process interest subvention on monthly basis through Direct Benefit Transfer (DBT) mode.

So far, a total of 34 States/UTs and 275 Lending Institutions are on-boarded on the Portal. So far, 2.8 lakh beneficiaries of the Mission have received interest subvention amounting to ₹114 crore till March, 08, 2021. Statement showing state-wise details of interest subvention paid through PAiSA Portal is annexed.

(c) & (d): This Ministry has been implementing a Centrally Sponsored Scheme, namely, "Deendayal Antyodaya Yojana - National Urban Livelihoods Mission (DAY-NULM)" to reduce poverty and vulnerability of urban poor households by enabling them to access gainful self-employment and skilled wage employment opportunities, for improvement in their livelihoods on a sustainable basis. Further, the mission aims at providing shelters equipped with essential services to the urban homeless and addressing livelihood concerns of the urban street vendors by facilitating access to suitable spaces, institutional credit, social security, etc.

Ministry has launched in June, 2020 PM Street Vendor's Atma Nirbhar Nidhi (PM SVANidhi), a Special Micro-Credit Facility Scheme for providing affordable loan to street vendors to resume their livelihoods that have been adversely affected due to Covid-19 lockdown.
