**MUNICIPAL SOLID WASTE MANAGEMENT**

**NO. 2470. SMT. VANDANA CHAVAN:**

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of cities practising scientific disposal of the municipal solid waste, State-wise/UT-wise;
- (b) the details of quantity of treated and untreated waste in the country, State-wise/UT-wise;
- (c) the details of infrastructure being developed to enable scientific treatment and management of solid waste, State-wise/UT-wise;
- (d) the details of funds sanctioned and disbursed to municipal corporations for support in Solid Waste Management (SWM), State-wise/UT-wise;
- (e) details of steps taken by Government to aid in SWM by cities; and
- (f) the details of steps taken to ensure abolition of manual scavenging and inclusion of manual scavengers in programs for scientific treatment of solid waste?

**ANSWER**

(a) to (d): State-wise/UT-wise details of waste treated, untreated, infrastructure developed to enable scientific treatment and management of solid waste, funds sanctioned and disbursed for support in Solid Waste Management (SWM) is placed in annexure.

(e): Under Swachh Bharat Mission – Urban (SBM-U), Central Assistance/Grants-in-aids up to 35% of the SWM project cost approved by State High Power Committee (SHPC) are provided to States/Union Territories for implementation of SWM activities.

(f): One of the targets of SBM (U) is to eliminate the cause of manual scavenging by converting all insanitary latrines into sanitary latrines. Now, with successful completion of target of toilets construction under SBM-U, it is expected that no person is involved in manual scavenging of human excreta. States/UTs have been advised to bring these erstwhile manual scavengers in main stream of the society and engage them formally in collection, transportation and processing of solid waste.
