PREPARATION FOR THE THIRD WAVE OF COVID-19 PANDEMIC

2484. SHRI BIKASH RANJAN BHATTACHARYYA:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) how long it further takes to completely vaccinate the citizens with both the doses;
- (b) the data on the vaccine supply from 2020 to 2021, State-wise, monthly-wise;
- (c) the data of vaccination status of single dosage and double dosage, State-wise till date; and
- (d) the specific measures taken to take care of the people from third wave of spreading particularly when the complete vaccination is a faraway dream?

ANSWER

- (a) to (d) COVID-19 vaccination is an ongoing and dynamic process, which is being guided by National Expert Group on Vaccine Administration for COVID-19 (NEGVAC) on the basis of concurrent scientific evidence. It is expected that eligible beneficiaries aged 18 years and above will be vaccinated by December 2021.

Since the commencement of National COVID-19 Vaccination Programme in January 2021, State-wise details of COVID-19 vaccines made available from January 2021 to 5th August 2021, is at **Annexure I**.

State-wise COVID-19 vaccination status, as on 5th August 2021 is at **Annexure II**.

Ministry of Health & Family Welfare continues to monitor COVID-19 trajectory right up to the District level. The guiding principle to minimize and avert the risk of future resurgence of cases is the 5-fold strategy of Test-Track-Treat-Vaccinate and COVID Appropriate

Behaviour. Besides this States are also being provided requisite technical and financial support by the Government of India to prepare for and respond to any exigencies arising out of surge in Covid-19.

Government of India also has supported the States/UTs by providing them Ventilators, Oxygen cylinders, PSA (Pressure Swing Adsorption) plants, Drugs and Diagnostics as well as financial assistance for augmentation of hospital infrastructure.

The isolation bed capacity and ICU bed capacity which was only 10,180 and 2,168 as on 23rd March 2020 in being enhanced continuously and is currently at 1,803,266 isolation beds and 124,598 ICU beds (as on 5th August 2021).

Support to State/UT level for ramping up Health Infrastructure including those in rural, tribal and peri-urban areas closer to the community, providing support for procurement of drugs and diagnostics to enhance service delivery at district and sub district levels for management of COVID-19 cases (including pediatric care) and for maintaining a buffer of drugs, support for IT Interventions such as implementation of Hospital Management Information System and expanding access to tele-consultations in all districts, and support for capacity building and training for all aspects of management of COVID-19.

In addition to above, a new scheme 'India COVID-19 Emergency Response & Health System Preparedness Package: Phase-II (ERCP-II)' amounting to Rs 23,123 crore has been approved for Financial year 2021-22 that aims to prevent, detect and respond to the continuing threat posed by COVID-19 and strengthen national health systems for preparedness in India for all.

Ministry of Health & Family Welfare continues to provide technical guidance for managing various aspects of COVID-19. Further COVID-19 treatment protocols and advisories both for adults as well as pediatric age groups were issued and widely disseminated to promote rational use of drugs and oxygen.
