Cesses imposed on petrol and diesel

2688 # Shri Sushil Kumar Modi:

Will the Minister of *Petroleum and Natural Gas* be pleased to state:

- (a) the cesses imposed on petrol and diesel;
- (b) the year-wise revenue collected from each cess during the last three years i.e 2018-19,2019-20, 2020-21;
- (c) the year-wise revenue received each year from 2018-19 to 2020-21 separately from Basic Excise Duty and Special Additional Excise Duty on petrol and diesel; and
- (d) the details of revenue shared with States out of total excise duty received during the last three years?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI RAMESWAR TELI)

(a) to (c): The Central Government levies Excise/Cess on Petrol of Rs.32.90/litre which includes Basic Excise Duty of Rs. 1.40, Road & Infrastructure Development Cess of Rs.18, Agriculture and Infrastructure Development Cess of Rs. 2.50 and Special Additional Excise Duty of Rs.11.

The current Central Excise/Cess on Diesel is Rs.31.80/ litre which includes Basic Excise Duty of Rs.1.80, Road & Infrastructure Development Cess of Rs.18, Agriculture and Infrastructure Development Cess of Rs. 4 and Special Additional Excise Duty of Rs. 8. The total excise duty/cess incidence as percentage of retail selling on petrol and diesel is 32.4% and 35.4% respectively, as on 16th July 2021.

The State wise VAT (Rs./litre) on petrol and diesel is at **Annexure**. This indicates the amount collected by each State on 01.07.2021 for a litre of petrol and diesel.

The year-wise revenue collected as Excise duty on all petroleum products during the last three years i.e. 2018-19, 2019-20, 2020-21 is given below:
