- (a) the total number of Kendriya Vidyalayas which have been announced to be set up in the country, especially in Rajasthan during the last three years, and district-wise details of the Kendriya Vidyalayas announced and currently functioning in Rajasthan;
- (b) by when the construction work of the buildings of such schools are likely to start, alongwith the timeline for completion thereof; and
- (c) whether there is any hindrance in the construction of such buildings, if so, the details thereof?

(a) During the last three years i.e. 2018-19 to 2020-21, 69 Kendriya Vidyalayas (KVs) have been approved under Civil, Project & Institute of Higher Learning sectors in the country.

district and state-wise details of the 69 KVs are at **Annexure I.**

Out of the above 69 KVs approved in the last 3 years 2(two) KVs are in Rajasthan and both are currently functioning, namely:-

- 1. KV Railway Colony Bandikui, District Dausa
- 2. KV Pratapgarh, District Pratapgarh

At present there are 77 KVs functioning in Rajasthan. The district-wise details are given at **Annexure-II.**

- (b) Out of the above 63 Civil Sector KVs, construction work has started in 2 KVs i.e. KV Baoli in Baghpat and KV CISF Surajpur, Greater Noida. The remaining are at planning stage as ongoing construction work of previously sanctioned KVs is given priority.
- (c) Construction of permanent buildings for KVs is a continuous process, which depends upon identification of suitable land, completion of lease formalities in favour of KVS by the sponsoring authorities, submission of drawings / estimates by construction agency, requisite approvals and availability of funds etc.
