- (a) the total number of beneficiaries enrolled under Pradhan Mantri Matru Vandana Yojana (PMMVY) for the year 2019-20 and 2020-21;
- (b) the number of beneficiaries who have received all three instalments under PMMVY out of the total number of beneficiaries enrolled for the period 2019-20 and 2020-21;
- (c) the number of beneficiaries who received two instalments under PMMVY for the years 2019-20 and 2020-21; and
- (d) the number of beneficiaries who have received only one instalment under PMMVY for the period between 2019-20 and 2020-21?

**Statement referred to in reply to part (a) to (d) of the Rajya Sabha Starred Question No. 43 for answer on 22.07.2021 raised by Dr. Amar Patnaik regarding Beneficiaries enrolled under PMMVY**

(a) to (d) Pradhan Mantri Matru Vandana Yojana (PMMVY) is a Centrally Sponsored Scheme under which maternity benefit of Rs.5,000/- is provided in three instalments to eligible Pregnant Women & Lactating Mothers (PW&LM) during the period of pregnancy and lactation. The eligible beneficiary also receives the remaining cash incentive as per approved norms towards maternity benefit under Janani Suraksha Yojana (JSY) after institutional delivery so that on an average, a woman gets Rs.6,000/-.

The Ministry periodically reviews the scheme implementation status with States/UTs and issues advisory from time to time to take appropriate steps to ensure all eligible women are enrolled after verification of the credential as per the scheme guidelines and then accordingly, transfers the maternity benefit directly to the Bank/Post Office account of the beneficiary.

The total number of beneficiaries enrolled under the Pradhan Mantri Matru Vandana Yojana (PMMVY) during the years 2019-20 and 2020-21 is as under:
