Setting up MSM Es under PMM Y

746. Shri Neeraj Dangi:

Will the Minister of Micro, Small and Medium Enterprises be pleased to state:

- (a) details of the Micro, Small and Medium Enterprises (MSMEs) set-up in the country particularly under Pradhan Mantri Mudra Yojana (PMMY) during the last three years, State-wise and year-wise;
- (b) the total turnover of these units during each year of the said period; and
- (c) the details of funds released by the Central Government to Rajasthan Government for the establishment of MSMEs during the last three years, year-wise?

ANSWER

MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI NARAYAN RANE)

- (a) & (b): Pradhan Mantri Mudra Yojana (PMMY) is a Flagship Programme of the Government of India aimed at funding the unfunded micro enterprises and small business. This is under the administrative domain of Ministry of Finance, Department of Financial Services. Under this scheme, institutional credit up to Rs 10 lakh is provided for entrepreneurial activities to micro/ small business units by Member Lending Institutions (MLIs) viz. Scheduled Commercial Banks (SCBs), Regional Rural Banks (RRBs), Non-Banking Financial Companies (NBFCs) and Micro Finance Institutions. As per the data uploaded by MLIs on Mudra Portal, over 17.28 crore loan accounts amounting to Rs 9.80 lakh crore have been sanctioned across the country during FY 2018-19, FY 2019-20, FY 2020-21. State-wise details of the loans given under this scheme is given in the Annexure-I.
- (c): All the schemes of Ministry of MSME are Central Sector Scheme where there is no scope for state-wise allocation of funds. However, the benefits of schemes of Ministry of MSME are available across the country including the State of Rajasthan. The details of achievements under various schemes in Rajasthan (during the last three years) are given in Annexure-II.
