- (b) if so, what steps have been taken to stop/to get stopped this continuous loss of livestock;
- (c) whether any project is being run by the Central Government itself for the protection and utilization of animals;
- (d) if not, whether any assistance is being provided to the projects running in the States; and
- (e) whether there is any provision to provide assistance to States; if so, the details thereof for the last three years?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI TASLIMUDDIN): (a) and (b) The movement of healthy animals for purposes of slaughter is not worrisome so long as it is in conformity with law.

(c) to (e) The Government is running a number of schemes, both in Central Sector and Centrally sponsored, for protection of animals from disease and improving productivity, leading to their better utilization. The expenditure on various such animal husbandry and dairying schemes was Rs.412.64 crores in 2004-05, Rs.418.52 crores in 2005-06 and Rs.515.36 crores in 2006-07.

(c) A comprehensive credit policy was announced on 18th June 2004 to double the flow of credit to the agriculture sector in three years. From Kharif 2006-07, farmers are provided crop loan upto Rs. 3.00 lakh at 7 per cent rate of interest and the Government of India and State Governments would provide necessary interest subvention to NABARD and Banks for this purpose. A sum of Rs. 1,677 crore has been provided in the Union Budget 2007-08 for this purpose. The Special Rehabilitation Package launched in 31 specially distressed districts in four States includes debt relief to farmers also.
