AYUSH dispensaries, hospitals and AYUSH educational institutions in Jharkhand

173 SHRI DHIRAJ PRASAD SAHU:

Will the Minister of **AYUSH** be pleased to state:

- (a) the total number of AYUSH dispensaries, hospitals and AYUSH educational institutions in the State of Jharkhand, district-wise;
- (b) the details of the funds allocated to the various schemes aimed at promoting Ayurveda system of medicine during the last three years, district-wise;
- (c) the details of amount allocated/spent and not utilised by the States and UTs during the said period and the reasons for not spending the entire amount thereon; and
- (d) the steps taken by Government to spend the entire amount in a time bound manner and to strengthen the AYUSH educational institutions?

ANSWER THE MINISTER OF STATE OF THE MINISTRY OF AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (SHRI MAHENDRABHAI MUNJAPARA)

- (a): The total number of AYUSH dispensaries, hospitals and AYUSH educational institutions in the State of Jharkhand, district-wise is furnished at **Annexure-I.**
- (b) & (c): Ministry of AYUSH is implementing Centrally Sponsored Scheme of National AYUSH Mission (NAM) through State/UT Governments and providing financial assistance to them for development and promotion of AYUSH system of medicine including Ayurveda as per the proposals received in their State Annual Action Plans (SAAPs). Under NAM funds are being released to State/UT Governments against the approved SAAPs. However, funds are not released district-wise. The State/UT-wise status of funds allocated/spent and unspent during the last three years is furnished at **Annexure-II.** Implementation of scheme comes under the purview of respective State/UT Governments. Different States/UTs have different issues as far as implementation is concerned. However, Ministry of AYUSH has continuously pursued with State/UT Governments for expediting the progress of implementation of the activities and utilization of funds under NAM.

(d): Ministry of AYUSH in coordination with the State/UT Governments ensure complete utilization of funds allocated under the National AYUSH Mission by timely approval of the State Annual Action Plan (SAAP) and the release of grant to the States/UTs. NAM also focus on implementation efficiency and absorption capacity of the States through setting up of State AYUSH Societies and strengthening of State as well as District Programme Management Units with adequate staff and infrastructure for implementing and monitoring the mission activities. Regional Review Meetings were conducted for different States/UTs to review the progress of National AYUSH Mission, expenditure and pending UCs. Ministry has also constituted teams for conducting field visits to review the physical progress of approved activities in the States/UTs.

Further, under NAM, there is also provision of financial assistance for strengthening/upgradation AYUSH educational institutions and State/UT Governments may avail eligible financial assistance by projecting the same through State Annual Action Plan (SAAP) as per NAM guidelines.
