- (d) the subsidies borne by Government under this scheme so far?

(a): The One Nation One Ration Card (ONORC) plan is not implemented so far in 3 States of Assam, Chhattisgarh and West Bengal.

(b): During the year 2021-22, the Department is allocating foodgrains to all States/UTs for monthly distribution to about 79.51 Crore beneficiaries presently covered by the States/UTs under the National Food Security Act, 2013 (NFSA). Accordingly, in the year 2021-22 so far, a total of 129.35 LMT foodgrains have been allocated by the Department. Further, the responsibility of distribution of foodgrains to beneficiaries lies with the respective State/UT Government. A State/UT wise statement showing allocation of foodgrains in 2021-22 is at Annexure-I.

(c): So far, about 15,700 transactions have been performed by the beneficiaries of Bihar outside the home State during the year 2021-22 under ONORC plan. A sale State/UT wise statement showing these inter-State transactions by beneficiaries of Bihar is at Annexure-II.

(d): Under ONORC plan, seamless portability of ration is provided to beneficiaries covered under NFSA, who receive foodgrains at highly subsidized rates. There is no fresh/ additional subsidy under ONORC.
