- (d) the details and number of SC/ST Judges in High Courts across the country, State-wise details with percentage of SCs/STs representation?

(a) to (b): A Statement showing sanctioned strength of Judges and vacancies in the Supreme Court and High Courts as on 20.07.2021 is at **Annexure.**

(c) to (d): Appointment of Judges of the Supreme Court and High Courts is made under Articles 124, 217 and 224 of the Constitution of India, which do not provide for reservation for any caste or class of persons. Hence no class/category wise date is maintained centrally. However, the Government has been requesting the Chief Justices of High Courts that while sending proposals for appointment of Judges, due consideration be given to suitable candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Minorities and Women to ensure social diversity in appointment of Judges in High Courts.
