## Female participation in judicial process

# 1219. SHRI SANJAY SETH: SHRI K.C. VENUGOPAL:

Will the Minister of LAW AND JUSTICE be pleased to state:

- (a) the details of the number of women who are currently serving as Judges in the Supreme Court, High Courts and at the district level, State/UT-wise;
- (b) whether Government gives reservation to women while appointing Judges in courts and if so, the details thereof;
- (c) whether there is a shortage of female Judges in the courts at all levels including the Supreme Court in the country;
- (d) if so, the measures being taken by Government to increase female participation in judicial process; and
- (e) whether Government would consider implementing reservations to increase the representation of women in the judiciary?

#### **ANSWER**

#### MINISTER OF LAW AND JUSTICE

## (SHRI KIREN RIJIJU)

(a) to (e): A Statement showing working strength of female Judges in the Supreme Court and High Courts as on 20.07.2021 is at **Annexure.** As per Constitutional framework, the selection and appointment of Judges in Subordinate Courts is the

responsibility of the concerned High Courts and State Governments and data on female judges is not centrally maintained.

Appointment of Judges of the Supreme Court and High Courts is made under Articles 124, 217 and 224 of the Constitution of India, which do not provide for reservation for any caste or class of persons. Hence no class/category wise date is maintained. However, the Government has been requesting the Chief Justices of High Courts that while sending proposals for appointment of Judges, due consideration be given to suitable candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Minorities and Women to ensure social diversity in appointment of Judges in High Courts.
