**CONCERNS OVER POSHAN ABHIYAAN APP**

1264 SHRI SANJAY SINGH:

Will the Minister of Women and Child Development be pleased to state:

- (a) whether it is a fact that the new Poshan Abhiyaan tracker app has caused severe distress amongst Anganwadi Workers in the country who have not been provided any mobile phones or money for recharge of internet packages by Government;
- (b) if so, the details thereof and the reasons for making it compulsory to download this app;
- (c) whether it is also a fact that many Anganwadi Workers in Punjab have not been paid their dues and incentives since March, 2018; and
- (d) if so, the details thereof and the reasons therefor?

**ANSWER**

(a) & (b) Poshan Tracker management application provides a 360-degree view of the activities of the Anganwadi Centre (AWC), service deliveries of Anganwadi Workers (AWWs) and complete beneficiary management for pregnant women, lactating mothers and children. Simultaneously, the mobile application also digitizes and automates physical registers used by AWWs that helps improving their quality of work.

Poshan Tracker application has been built on latest technology for ensuring real time monitoring of provisioning supplementary nutrition for improving nutritional status of beneficiaries and for prompt supervision and management of services.

It aims at empowering the AWWs with the provision of Smartphones procured through Government e-Market (GeM) for efficient service delivery. States/UTs are advised to introduce transparent processes for procurement of mobile phones as per GFR and vigilance guidelines. A total of 8.66 lakhs Smartphones have been procured by 32 States/UTs. Further, each AWW and Lady Supervisor (LS) have also been provided ₹200/- per month for recharging of smart phones. To encourage AWWs and AWHs an incentive of ₹500/- and ₹250/- respectively is being paid on the basis of their monthly performance.
